**Subject: FEES AND CHARGES OF RECOGNIZED ORGANISATIONS OF TZIRS REGISTERED SHIPS**

Reference: Maritime Transport Act, No. 5 2006,  
Maritime Transport (Fees & Charges) Regulations, 2020



1. The purpose of Marine Circular is to inform our stakeholders the fees and charges for surveying companies and recognized organizations authorized by our Administration to perform statutory surveys, certification and document approval to vessels registered under TZIRS on behalf of United Republic of Tanzania.
2. Any surveying companies or recognized organizations authorized by our Administration may use their own fees and charges or those issued by Authority under prescribed Maritime Transport (Fees and Charges) Regulations, 2020 for providing services of statutory survey/audit, certification and document approvals to Tanzania registered ships.
3. Any surveying companies or recognized organizations wish to use different fees or charges other those prescribed in the Regulations are required to submit their proposals to the Director General for approval.
4. Any approved proposal of fees and charge of surveying company or recognized organisation should be regarded as applicable fees and charges for that surveying company or organisation.

5. Surveying companies or recognized organizations authorized by our Administration are required to pay 10 percent of their actual amount they charge from ship-owners or companies for the work of survey, audit, certification and document approval or certificate issued to any Tanzania Zanzibar ship.
6. The payment of fees under section 5 of this Circular should be made to the Authority two weeks following the submission of the monthly report required under Circular No.FSI/02/2019.
7. This Circular is issued and effective from 1<sup>st</sup> December, 2021.
8. This Circular cancels Circular No. FSI /011/2017 issued on 30<sup>th</sup> May 2017.
